WORKFORCE EDUCATION AND DEVELOPMENT

Entrance Criteria for Options: Industrial Education; Occupational Home Economics; Health Occupations

ENTRANCE CRITERIA to be met by the end of the sophomore year, prior to fifth semester classification:

1. Cumulative grade point average of at least 3.00. (Note that Industrial Training option requires 2.00 GPA)
2. Present scores from *the PRAXIS I - - PPST Reading and PPST Writing*.
3. Earn at least a "C" in each course identified with a bullet (•) on the front page.
4. Document at least 80 hours of paid or volunteer education work experience with learners of the age group the candidate plans to teach, including 40 hours of these age-appropriate 80 hours with learners whose cultural, social, or ethnic backgrounds differ from the candidate's own. (The 4000 hours paid occupational work experience will meet this requirement.)

EXIT CRITERIA: Candidates for the baccalaureate degree and a Pennsylvania teacher certificate must complete the:

1. Academic program requirements, including the 4000 hours paid occupational work experience.
2. Pre-Certification Competency Exam on Educating the Handicapped.
3. Tests and clearances as required by the Pennsylvania Department of Education.
