ANALYSIS OF LEGISLATION

- 2010 *Analysis of HB 3 Relating to public school accountability*
This analysis of the bill focused on the need to include a growth measure in the accountability system so that middle- and high-schools are not unduly punished for having low-performing students entering their school. Further, the analysis showed that the opening of magnet, charter, and early-college high schools was a further concentrating low-performing students in a small set of schools.

Analysis of Charter Schools

This analysis focused on the high-performing and well-known charter school chains in Texas. The analysis showed that high-performing schools did not enroll many low-performing students, tended to lose the lowest performing students, and overall had relatively high student-attrition rates. The purpose of the analysis was to show that increasing the number of charter schools will not solve the problem of low-performing schools in urban areas.

Principal Turnover and Preparation

This presentation was requested by the Chairman of the House Public Education Committee. The purpose of the presentation was to review principal turnover and the causes of such turnover. In addition, the presentation made policy recommendations to improve principal retention and effectiveness.

Improving Middle School Achievement

This presentation was requested by the Chairperson of the Senate Education Committee. My testimony focused on the importance of preparing students to be high school ready and the strategies used by successful high-performing middle schools.

Improving Middle School Achievement

This presentation was requested by the Chairperson of the Senate Education Committee. My testimony focused on the importance of preparing students to be high school ready and the strategies used by successful high-performing middle schools. Finally, the presentation offered policy solutions to improve middle school performance.

STEM Teachers and STEM Education

This presentation focused on the lack of well-qualified STEM teachers and how the lack of quality teachers affects overall STEM achievement. In particular, the presentation focused on the low entrance requirements of alternative certification programs and the disincentive for private/for-profit programs to produce effective teachers.

Analysis of HB 3 Relating to public school accountability

This analysis of HB 3 for Representative Harold Dutton focused on the section of the bill related to school improvement. At the request of Representative Dutton, I attended several meetings with high-level policymakers and critiqued past and proposed bill language about how the state should sanction and support low-performing schools.

Analysis of HB 3 Relating to public school accountability

This analysis of HB 3 for Representative Mike Villarreal focused on the section of the bill related to the section on improving low-performing schools. My analysis suggested that the state should require any district with a low-performing school to conduct an equity audit regarding the distribution of teacher qualifications and turnover. The engrossed version of this bill included language that required such an equity-audit for all districts with a school rated as low-performing under the state's accountability system.

Analysis of HB 3 Relating to public school accountability

This analysis of HB 3 for House Public Education Committee Chairman Rob Eissler focused on all sections of the bill related to teacher and administrator quality and turnover. In addition, my analysis included a review of the factors associated with schools being rated as low-performing. Specifically, I utilized student-level data to show that the strongest predictor of high schools being rated low-performing was the 8th-grade achievement of incoming 9th-grade students.

Analysis of HB 3 Relating to public school accountability

This analysis of HB 3 for the House Public Education Committee and Senate Education Committee focused on the relationship between low teacher qualifications and low-performing schools. The analysis suggested that low teacher qualifications were associated with low school performance. My suggestion was to transfer over \$200 million from one teacher incentive program that had been determined to be ineffectual and to another teacher incentive program that could be used more readily to attract and retain well-qualified teachers in low performing schools.

Analysis of HB 3421 (HB 174), Relating to educator preparation programs and educator certification, performance, and recruitment.

At the request of the Honorable Rob Eissler, Chairman of the House Public Education Committee, I analyzed HB 3421. I made numerous suggested changes and met with Chairman Eissler and his staff members several times. I also spoke at length with members of the Texas Education Agency about their perceptions about how to improve the educator preparation program accountability system. Finally, I suggested a substantial amount of bill language and much of this language appeared in the final bill. The final bill was inserted into HB 174 and passed by the legislature and signed by the Governor.

Analysis of HB 3568 Relating to information for prospective teachers regarding the effectiveness of educator preparation programs.

In this analysis for Representative Olivo, I made recommendations to the Representative's staff members about what information could and should be collected about teacher preparation programs.

Analysis of HB 1313 Relating to the assignment of a public school student to an uncertified teacher.

In this analysis for Representative Giddings,, I used state databases to show that students in high-poverty and low-performing schools were far more likely than students in other schools to be taught by teachers assigned out-of-field or who did not hold a full state certificate. In addition, I reviewed the research on the relationship between teacher certification and student achievement.

Analysis of HB 130 Relating to an enhanced quality full-day prekindergarten program provided by public school districts in conjunction with community providers.

In this analysis for Representative Diane Patrick's office , I used state data bases to determine if there was an adequate supply of fully certified pre-kindergarten teachers. The results of this analysis were used to remove language that would have allowed uncertified teachers to instruct students in pre-kindergarten classes.
